



SCEGLIGESÙ SCHOOL RULES

Art. 1 AIM AND PURPOSE

Scegligesuschool is a voluntary initiative promoted by International Sabaoth Ministries. Its purpose is to evangelize and to present the message of Christ in Italy and in Europe.

Art. 2 LEADERSHIP

Each person that will participate in Scegligesuschool will conscientiously follow all the instructions given by Past. Roselen Boerner Faccio and by all the other leaders designed by International Sabaoth Ministries.

Art. 3 PERSONAL COMMITMENT

Each participant, being aware of the aim and purpose of the Scegligesuschool, commits to behave according to the principles of faith, morality and ethics pursued by International Sabaoth Ministries and to make these principles his own. Each participant recognizes that through his behavior he is not only representing himself, but also Sabaoth Ministries. For the purposes of the foregoing, the participation requires a period of at least six months from one's conversion of faith.

Art. 4 RULES OF BEHAVIOR

In order to respect the inspiring principles of the Scegligesuschool, as well as for obvious requirements of legality, safety and security of each participant, it will be expressly forbidden:

- to purchase and/or own and/or take drugs of any kind;
- carry out any unlawful behavior according to Italian law, as well as in accordance with the laws in force in each other country crossed;
- to purchase and/or own and/or drink alcohol of any kind;
- to have sexual relationships or behaviors of sexual nature;
- to act dangerously for the safety of oneself and of others;
- to have a vulgar and offending behavior.

In addition to what is expressly indicated, it will be the responsibility of each participant to avoid any other behavior that is contrary to or inopportune to the guiding principles of the initiative.

Art. 5 PERSONAL NEEDS

Whatever particular personal needs that may have relevance in relation to the initiative, must be communicated to the leaders. The Scegligesuschool does not take charge of the personal needs of the members.



Art. 6 HEALTH CONDITIONS

Each participant takes part in the Scegligesuschool declaring under his own responsibility to be in good health and able to perform the kind of activities planned during the initiative, on which he confirms that he has been promptly informed.

Art. 7 IMPLEMENTING OF THE INITIATIVE

The program of the Scegligesuschool and ways of execution may undergo variations during the course of the initiative itself depending on situations or choices of the leaders. This does not imply in any way a change in the commitment undertaken by each participant.

Art. 8 RESPONSIBILITY

Each participant will take part in the initiative under his own responsibility, knowing that the participation at the Scegligesuschool has the purpose to carry out voluntary activities in order to evangelize and spread the Christian message.

Art. 9 PAYMENT OF THE PARTICIPATION FEE

The enrollment fee for the first year of Scegligesù School amounts to a total value of **€ 4400** for the whole year, from October to August, paid in monthly fees of **€ 400** for **11 months**.

Art. 10 REFUND AND RETENTION FOR PARTECIPATION CANCELLATION

In case of cancellation of the participation to Scegligesù School, if the cancellation will be made no later than 60 days before the start of the school year, the participant will lose the first monthly fee. In any other case the participant will have the obligation to pay the full fee of the current year.

Art. 11 VIOLATION OF RULES AND INCOMPATIBILITIES

In case of violations of this rules and/or events or behaviors such as to determine situations of incompatibility of the participant or of several participants according to the inspiring principles or the organization of the scegligesuschool, the leaders of the initiative - after having gathered all necessary information and heard the binding opinion of the Past. Roselen Boerner Faccio - will be able to impose the removal of the person/people who are incompatible with the initiative, by providing exhaustive and precise reasons for the taken decision.

If the removal concerns participants who are minors, the leaders will procede with the most caution in order to ensure their safe return to home. In case of expulsion, the participant will not be entitled to any financial reimbursement, including any expenses or costs for the early return. Likewise, if the abandonment of the school becomes necessary for any other cause, the International Sabaoth Ministries will not be required to reimburse any amount, for any reason.

Art. 12 KNOWLEDGE AND ACCEPTANCE OF THE RULES WITHOUT RESERVATIONS

Each participant accepts these Rules and commits to adhere to them without reservation, being fully aware and conscious, having entirely known and understood these rules.
